# Rep Report for January, 2021

This report highlights some of the recent initiatives at the ACA World Service Organization, in particular, developments that relate directly to our meeting. The report also features various online resources available to members and meetings and may announce opportunities to be of service to the WSO.

## The Monthly Board Meeting, Jan. 9, 2021 – 43 participants, including 8 Board members

The Board of the World Service Organization holds a business meeting, online, on the 2nd Saturday of each month, open to all ACA members. Audio recordings of each meeting may be found at acawso.org

Here are some highlights that stood out this month:

- The Board has made some motions outlining Committee rules and procedures, in particular, looking at Chair eligibility and term limits, as well as reporting requirements.
- The H&I (Hospitals and Institutions) Committee has developed new literature aimed at healthcare professionals, outlining the ACA program.
- Ballots listing the Proposals being considered for inclusion on the Annual Business Conference
  agenda are now being sent to the meeting contacts for all groups to cast their opinions. There will
  be 3 opportunities to get more information about the Proposals at townhall-styled Q & A sessions
  through February before the voting commences. Our group has submitted a proposal. We will
  want to decide, as a group, how to address voting on the Ballot of Proposals.
- The website, adultchildren.org is in the midst of a makeover, an update.
- Reference was made of the Virtual Meetings Subcommittee of the Member Services Committee.
   A participant mentioned involvement on the Subcommittee, which was initiated after the 2017
   ABC, to address issues particular to the world of phone and virtual meetings.

   [Note: Subsequent investigation showed that the original Subcommittee disbanded in 2019, due to lack of interest. A recommendation was made that, in the future, an online/telephone Intergroup could form to address all the pertinent issues.]
