## Overview

In July, we received \$1,026.46 in member contributions via PayPal. \$800 was disbursed: \$600 was paid to the WSO General Fund and \$200 was paid to the WSO International Literature Scholarship Fund. The only expense for the month of July was a \$199.90 Zoom charge. Question: Did we change our Zoom account? This charge is usually \$50/month.

As of June report, there was \$574 accumulated in our group's CashApp. I have been unable to get into the account. I have asked Jim, my Co-treasurer, about this. We will resolve this in the coming month and transfer the existent funds that are there to PayPal.

I also asked the past Treasurer, Adam, to review the work that I have been doing these past months since it involves using a spreadsheet that he created. In his review process, he let me know that CashApp donations sometime need to be accepted. Once we have resolved the access issue, I will make sure that I check that account regularly to accept any contributions we receive there.

Current amount in the PayPal account as of the date of this report is \$1,000.15. This includes August donations totaling \$364.65 as of the date of this report. Less the minimum prudent reserve amount of \$350, that leaves an additional \$285.50 in available funds in our PayPal account.
