Overview

I was not able to prepare this report in time for the business meeting today and was also absent at the October business meeting. I am submitting this report which will account for donations and expenses from both September and October, 2024.

In September, we received \$424.94 in member contributions via PayPal. \$350 was disbursed this month: \$262.50 was paid to the WSO General Fund and \$87.50 was paid to the WSO International Literature Scholarship Fund. We had two expenses for the month: \$28.85 for our Mailchimp account and \$50 for Zoom.

In October, we received \$475.56 in member contributions via PayPal. \$350 was disbursed this month: \$262.50 was paid to the WSO General Fund and \$87.50 was paid to the WSO International Literature Scholarship Fund. We had three expenses this month: \$28.85 for our Mailchimp, \$17.99 for dreamhost account and \$50 for Zoom.

Current amount in the PayPal account as of the date of this report is \$767.45. This includes November donations totaling \$213.63 as of the date of this report that have not yet been disbursed. Less the minimum prudent reserve amount of \$350, that leaves an additional \$203.82 in available funds in our PayPal account.
